This sweepstakes is in no way sponsored, endorsed, administered by, or associated with Meta or Facebook, nor by participating businesses where prizes are hidden. These businesses are only hosting the prize locations and are not involved in the administration or sponsorship of this sweepstakes.

Eligibility: No purchase necessary to win and will not improve the chances of winning. Participants must be 18 years of age or older. Plains Commerce Bank employees, employee family (immediate family members including a spouse, siblings, children, and parents including foster and step-relations), employee households (those living in the same house, whether related or not) and Plains Commerce Bank Board of Director members are not eligible.
